AS PART OF THE NATIONAL DEFENSE AUTHORIZATION ACT (NDAA) FOR FISCAL YEAR 2012, CONGRESS AMENDED 10 USC SECTION 1171 AUTHORIZING AN EARLY DISCHARGE OF REGULAR ARMY ENLISTED SOLDIERS UP TO 12 MONTHS (FORMERLY THREE MONTHS) UNDER REGULATIONS PRESCRIBED BY THE SECRETARY OF THE ARMY WITHOUT IMPACT TO ANY RIGHT, PRIVILEGE, OR BENEFIT THAT A MEMBER WOULD HAVE HAD IF HE OR SHE HAD COMPLETED HIS OR HER ENLISTMENT OR EXTENDED ENLISTMENT, EXCEPT THAT THE MEMBER IS NOT ENTITLED TO PAY AND ALLOWANCES FOR PERIODS NOT SERVED. THE ARMY IMPLEMENTED THE ABOVE AUTHORITY ON A VOLUNTARY BASIS ON 1 JANUARY 2014.
- 2.B. ON 16 DECEMBER 2016, THE ARMY G-1 RELEASED ALARACT MESSAGE 106/2016 (INACTIVE) CONTINUING THE ARMY'S ENLISTED VOLUNTARY EARLY SEPARATION PROGRAM.
