A. MILPER MSG 07-180, AHRC-EPF, 20 JULY 2007, SELECTIVE REENLISTMENT BONUS (SRB) - ENHANCED PROGRAM IS RESCINDED EFFECTIVE 29 AUGUST 2007.

B. AR 601-280, CHAP 5

1. THIS MILPER MESSAGE **WILL EXPIRE PRIOR TO 1 OCTOBER 2007** WITHOUT FURTHER NOTICE.

2. THIS MSG WILL BE BROUGHT TO THE IMMEDIATE ATTENTION OF ALL COMMANDERS, REENLISTMENT OFFICES, RECRUITERS, AND FINANCE AND ACCOUNTING OFFICES. THIS MESSAGE ANNOUNCES CHANGES TO THE REGULAR ARMY ACTIVE COMPONENT SRB PROGRAM. **THE EFFECTIVE DATE OF THIS MESSAGE IS 29 AUGUST 2007.**

IN ADDITION, SOLDIERS (REGARDLESS OF ETS) POSSESSING A CRITICAL SKILL LISTED IN PARAGRAPH 6 ARE ENTITLED TO A LUMP SUM FLAT-RATE SRB PAYMENT AS LISTED BELOW, WHO ARE:

A. ON ORDERS OR ASSIGNED TO A MILITARY TRANSITION TEAM (MiTT).

B. ASSIGNED TO A UNIT THAT IS DEPLOYED OR IN RECEIPT OF DEPLOYMENT ORDERS TO AFGHANISTAN, IRAQ, OR KUWAIT.

7. SFC IN CMF 18, MOS 11B, 37F, 38B, 79R, 89D, 96B, 96D, 96H, 97E, 98G AD AND THOSE MOS WITH SQI W/T" MAY REENLIST FOR THE SRB LISTED FOR SSG IF OTHERWISE QUALIFIED.

8. THE PROVISIONS OF PARAGRAPHS 4 AND 5 ARE SEPARATE ENTITLEMENTS; THEREFORE, A SOLDIER IS ONLY ALLOWED ONE BONUS AMOUNT AND CANNOT COMBINED THE TWO DIFFERENT BONUS AUTHORIZATIONS. IN ADDITION, SOLDIERS ELIGIBLE FOR A BONUS UNDER OTHER CURRENT SRB MESSAGES (I.E., SRB-DEPLOYED, SRB-INVENTORY, OR SRB-LOCATION), MUST CHOOSE WHICH SRB PROGRAM IS MORE ADVANTAGEOUS TO THE SOLDIER. SRB PROGRAMS CANNOT BE COMBINED, UNLESS SPECIFICALLY STATED IN THE MESSAGE.

9. SOLDIERS MUST HAVE COMPLETED AT LEAST 17 MONTHS OF CONTINUOUS ACTIVE DUTY (OTHER THAN ACTIVE DUTY FOR TRAINING AS A RESERVIST) BEFORE REACHING ELIGIBILITY TO RECEIVE AN SRB. COMPLETION OF THE 17 MONTHS OF CONTINUOUS ACTIVE DUTY NEED NOT OCCUR IMMEDIATELY BEFORE THE DATE OF REENLISTMENT. ZONE A INCLUDES SOLDIERS WHO HAVE BETWEEN 17 MONTHS AND 6 YEARS OF SERVICE AT TIME OF REENLISTMENT. ZONE B INCLUDES SOLDIERS WHO HAVE BETWEEN 6 AND 10 YEARS OF SERVICE AT TIME OF REENLISTMENT. ZONE C INCLUDES SOLDIERS WHO HAVE BETWEEN 10 AND 14 YEARS OF SERVICE AT TIME OF REENLISTMENT.

10. SRB ENTRY ON DD FORM 4/1: ITEM 8B(5) "LUMP SUM BONUS IAW MILPER MESSAGE 07-XXX".

11. SPECIAL CONSIDERATIONS AND TECHNICAL INFORMATION:

A. SOLDIERS MUST MEET ALL QUALIFICATIONS FOR SRB ENTITLEMENT IAW AR 601-280.

B. MOS'S THAT CONVERT OR MERGE INTO A NEW MOS: THE INCENTIVES THAT APPLIED TO THE OLD MOS WILL APPLY TO THE NEW MOS.

C. A SOLDIER WILL NOT FORFEIT ANY PORTION OF AN SRB WHEN THE SOLDIER IS RECLASSIFIED WITHIN THE SAME CMF OR INTO CMF 18, UNLESS OTHERWISE DIRECTED BY HRC.

D. SOLDIERS WHO REENLIST TO MEET THE SERVICE REMAINING REQUIREMENT FOR AN HQDA DIRECTED DETAILED ASSIGNMENT (SUCH AS RECRUITING, DRILL SERGEANT, OR INSTRUCTOR DUTY) ARE AUTHORIZED PAYMENT OF AN SRB FOR THEIR PMOS, SQI, ASI, OR LANGUAGE CODE, PROVIDED OTHERWISE QUALIFIED.

E. INFORMATION ON TAXABLE INCOME CAN BE FOUND IN TABLE 44-1, CHAPTER 44, VOLUME 7A OF THE DODFMR.

F. MGIB TRANSFERABILITY IS NOT AUTHORIZED UNDER THE SELECTIVE REENLISTMENT BONUS (SRB) - ENHANCED PROGRAM.

12. CAREER COUNSELORS ARE NO LONGER REQUIRED TO DISTRIBUTE A HARD COPY OF THE REENLISTMENT CONTRACT TO FINANCE. THIS INCLUDES REENLISTMENTS RESULTING FROM THE BEAR PROGRAM.

13. SOLDIERS WITH QUESTIONS PERTAINING TO BONUSES AND ELIGIBILITY REQUIREMENTS ADDRESSED IN THIS MESSAGE SHOULD CONTACT THEIR SERVICING CAREER COUNSELORS.
