SELECTIVE REENLISTMENT BONUS (SRB) - LOCATION PROGRAM

A. MESSAGE MILPER MSG 06-277, AHRC-EPR, ISSUED 6 OCT 06, SELECTIVE REENLISTMENT BONUS – LOCATION PROGRAM, IS RESCINDED EFFECTIVE 26 JANUARY 2007

B. AR 601-280, CHAP 5

1. THIS MILPER MESSAGE WILL EXPIRE NLT 31 DECEMBER 2007.

2. THIS MSG WILL BE BROUGHT TO THE IMMEDIATE ATTENTION OF ALL COMMANDERS, REENLISTMENT OFFICES, RECRUITERS, AND FINANCE AND ACCOUNTING OFFICES. THIS MESSAGE ANNOUNCES CHANGES TO THE REGULAR ARMY ACTIVE COMPONENT SRB PROGRAM. THE EFFECTIVE DATE FOR ADDITIONS TO SRB MULTIPLIERS IS 26 DECEMBER 2006. THE EFFECTIVE DATE OF DECREASES AND TERMINATIONS TO THE SRB PROGRAM IS 26 JANUARY 2007.

3. ADDITIONAL GUIDANCE FOR DFAS AND USAREC: TO AVOID FUTURE CLAIMS OR ERRONEOUS UNFULFILLED COMMITMENTS, REQUEST CDR ENSURE FAOS, RECRUITERS AND MEPS PERSONNEL ARE KNOWLEDGEABLE OF THE CONTENTS OF THIS MESSAGE.

4. THIS MSG CONTAINS MOS FOR LUMP SUM SRB PAYMENTS OF \$10,000, \$15,000, \$20,000, \$25,000, \$30,000, OR \$40,000. THE MAXIMUM PAYMENTS FOR MOS/LOCATIONS ARE IDENTIFIED IN PARAGRAPHS 10, 11 AND 12 UNDER COLUMN HEADING "MAXIMUM PAYMENT". PARAGRAPHS 13 THROUGH 15 ADDRESS PREPARATION OF DD FORM 4/1 AND CAREER COUNSELOR RESPONSIBILITY.

5. SOLDIERS MUST HAVE COMPLETED AT LEAST 17 MONTHS OF CONTINUOUS ACTIVE DUTY (OTHER THAN ACTIVE DUTY FOR TRAINING AS A RESERVIST) BEFORE REACHING ELIGIBILITY TO RECEIVE AN SRB. COMPLETION OF THE 17 MONTHS OF CONTINUOUS ACTIVE DUTY NEED NOT OCCUR IMMEDIATELY BEFORE THE DATE OF REENLISTMENT. ZONE A INCLUDES SOLDIERS WHO HAVE BETWEEN 17 MONTHS AND 6 YEARS OF SERVICE AT TIME OF REENLISTMENT. ZONE B INCLUDES SOLDIERS WHO HAVE BETWEEN 6 AND 10 YEARS OF SERVICE AT TIME OF REENLISTMENT. ZONE C INCLUDES SOLDIERS WHO HAVE BETWEEN 10 AND 14 YEARS OF SERVICE AT TIME OF REENLISTMENT.

6. THE SRB MULTIPLIERS LISTED IN THIS MESSAGE ARE TARGETED FOR SPC, SGT, AND SSG. THE FOLLOWING EXCEPTIONS APPLY:

A. PFC MAY REENLIST FOR THE A ZONE BONUS LISTED FOR SPC IN ACCORDANCE WITH AR 601-280, PARAGRAPH 5-6B(3).

B. SPC OR SPC(P) MAY REENLIST AND RECEIVE THE ZONE B SRB LISTED FOR SGT, IF OTHERWISE QUALIFIED. RETENTION CONTROL POINT EXCEPTIONS TO POLICY WILL NOT BE CONSIDERED TO QUALIFY SOLDIER FOR SRB.

C. SFC IN MOS 96B AND 97E MAY REENLIST FOR THE SRB LISTED FOR SSG IF OTHERWISE QUALIFIED.

7. SRB ASSOCIATED WITH AIRBORNE (SQI "P") AIRBORNE RANGER (SQI "V"), OR RANGER (SQI "G"): AN AIRBORNE OR RANGER QUALIFIED SOLDIER POSSESSING A MOS THAT IS INCLUDED IN THE SRB PROGRAM WITH SQI "P" (PARACHUTIST), "G" (RANGER), OR "V" (RANGER PARACHUTIST) AND WHO IS REENLISTING FOR AN ASSIGNMENT OR WILL CONTINUE TO SERVE IN A POSITION CODED "P", "G", OR "V" IS ENTITLED TO THE SRB ASSOCIATED WITH THE APPLICABLE SQI. THIS ENTITLEMENT INCLUDES SOLDIERS WHO POSSESS A HIGHER SQI BASED ON THE ORDER OF PRECEDENCE ESTABLISHED BY AR 614-200. IN ADDITION, SOLDIERS WHO REENLIST FOR THE ARMY TRAINING REENLISTMENT OPTION OR THE REGULAR ARMY REENLISTMENT OPTION TO MEET THE DA IMPOSED SRR FOR AIRBORNE OR RANGER TRAINING AND SUBSEQUENT ASSIGNMENT TO A POSITION CODED "P", "G", OR "V" ARE ENTITLED TO THE SRB ASSOCIATED WITH THE APPLICABLE SQI. HOWEVER, THESE SOLDIERS WILL NOT RECEIVE BONUS PAYMENT UNTIL THEY HAVE COMPLETED THE ASSOCIATED TRAINING AND ARE SUBSEQUENTLY ASSIGNED TO AN AUTHORIZED AIRBORNE OR RANGER POSITION AND PROVIDE DOCUMENTATION VERIFYING COURSE COMPLETION. FAILURE TO SUCCESSFULLY COMPLETE AIRBORNE OR RANGER TRAINING OR TO BE ASSIGNED TO AN AUTHORIZED AIRBORNE OR RANGER POSITION WILL RESULT IN RECOUPMENT OF THE SRB.

8. LOCATION SPECIFIC SRB PROGRAM:

A. ELIGIBLE SOLDIERS STATIONED AT DESIGNATED INSTALLATIONS, LOCATIONS, OR COMMANDS AND REENLIST OPTION (E-2), CURRENT STATION STABILIZATION REENLISTMENT OPTION, OR ARE ELIGIBLE AND REENLIST FOR A VALID POSITION AT ONE OF THE DESIGNATED INSTALLATIONS/LOCATIONS/COMMANDS WILL BE ENTITLED TO THE LOCATION SPECIFIC SRB AS OUTLINED IN THIS MESSAGE. SOLDIERS REENLISTING FOR A LOCATION SPECIFIC SRB WILL BE USED IN AN AUTHORIZED POSITION BASED ON MOS/ASI/SQI/LANGUAGE CODE, AS APPROPRIATE, FOR THE AUTHORIZED STABILIZATION PERIOD. SOLDIERS REENLISTING FOR LOCATION SPECIFIC SRB WILL RECEIVE PAYMENT AT TIME OF REENLISTMENT. SOLDIERS WHO FAIL TO COMPLETE THE STABILIZED PERIOD ARE SUBJECT TO RECOUPMENT OF THE SRB.

B. 75TH RANGER REGIMENT, SP OPNS CMD (SQI "P" SP OPNS CMD) OR 160TH SOAR: SOLDIER WILL BE STABILIZED FOR MINIMUM OF TWO YEARS UNLESS OTHERWISE DIRECTED BY HRC. STABILIZATION WILL COMMENCE ON DATE OF REENLISTMENT FOR SOLDIERS REENLISTING FOR CURRENT STATION. FOR SOLDIERS REENLISTING FOR AN ASSIGNMENT TO A DESIGNATED LOCATION, STABILIZATION WILL COMMENCE UPON ARRIVAL AT THE NEW DUTY ASSIGNMENT. HOWEVER, BONUS WILL NOT BE PAID UNLESS SOLDIER IS ASSIGNED TO THE 75TH RANGER REGIMENT, SP OPNS CMD (SQI "P" SP OPNS CMD) OR 160TH SOAR. FAILURE TO BE ASSIGNED TO AN AUTHORIZED POSITION IN THE 75TH RANGER REGIMENT, SP OPNS CMD (SQI "P" SP OPNS CMD) OR 160TH SOAR WILL RESULT IN THE RECOUPMENT OF THE SRB.

C. SOLDIERS ON AI TO ONE OF THE DESIGNATED INSTALLATIONS/LOCATIONS/COMMANDS (EXCLUDING EUROPE) LISTED IN THE SRB-INVENTORY PROGRAM WHO REENLIST REGULAR ARMY REENLISTMENT OPTION, E-1, (TO MEET THE SERVICE REMAINING REQUIREMENT (SRR)) CAN RECEIVE THE SRB PROVIDED THEY ARE OTHERWISE QUALIFIED. SOLDIERS REENLISTING TO COMPLY WITH AI TO ONE OF THE SELECTED LOCATIONS WILL NOT BE DELETED UNLESS SOLDIER WAIVERS THE HIGHER ENTITLEMENT AND APPROVED BY AHRC-EPR (RMB). CAREER COUNSELORS WILL ADVISE SOLDIERS WHO ARE REENLISTING TO COMPLY WITH AI AND ARE RECEIVING A LOCATION SPECIFIC SRB, THAT IF THEY ARE DIVERTED OR DELETED FROM THE DESIGNATED INSTALLATION/LOCATION/COMMAND, THEY SHOULD CONTACT THEIR SERVICING CAREER COUNSELOR OF THIS ACTION. CAREER COUNSELORS WILL CONTACT HRC, REENLISTMENT MANAGEMENT BRANCH FOR FURTHER GUIDANCE.

E. DD FORM 4/1, ITEM 8B "REMARKS" SECTION, FOR E-1 REENLISTMENTS WILL READ THE SAME AS IN AR 601-280, EXCEPT FOR BLOCK (2), WHICH WILL BE MODIFIED AS FOLLOWS: "SRB MULTIPLIER, MOS AND STATION". OMIT THE STATION INFO IN BLOCK (2) FOR E-2 AND E-5 REENLISTMENTS AS IT'S ALREADY IN BLOCK (1).

F. INSTALLATIONS WILL USE AEA CODE OF "V" TO STABILIZE SOLDIERS WHO REENLIST FOR OTHER THAN CURRENT STATION STABILIZATION. THE RETAIN REENLISTMENT CONFIRMATION PROCESS WILL SEND THE AEA CODE "U" AND TERMINATION DATE FOR THOSE SOLDIERS REENLISTING FOR CURRENT STATION STABILIZATION. THE DA FORM 3286, PART II WILL REFLECT STABILIZATION AS MENTIONED ABOVE. FOR SOLDIERS PFC-SFC REENLISTING REGULAR ARMY, THE DA FORM 3286 WILL REFLECT THE SAME.

G. SOLDIERS WHO REENLIST TO MEET THE SRR FOR A HQDA DIRECTED DETAILED ASSIGNMENT, TO INCLUDE RECRUITING, DRILL SERGEANT, OR INSTRUCTOR ARE NOT AUTHORIZED THE HIGHER LOCATION SPECIFIC SRB LEVEL AS OUTLINED IN THIS MESSAGE.

9. EFFECTIVE 26 DECEMBER 2006 THE FOLLOWING SRB MULTIPLERS ARE ADDED OR INCREASED FOR THE FOLLOWING MOS.

13. SPECIAL CONSIDERATIONS AND TECHNICAL INFORMATION:

A. FOR MOS'S THAT MERGE TO A NEW MOS, THE INCENTIVES THAT APPLIED TO THE OLD MOS WILL APPLY TO THE NEW MOS.

B. A SOLDIER WILL NOT FORFEIT ANY PORTION OF AN SRB WHEN THE SOLDIER IS NO LONGER CLASSIFIED IN THE BONUS SPECIALTY WHEN THE SOLDIER IS RECLASSIFIED WITHIN THE SAME CMF OR INTO CMF 18, UNLESS OTHERWISE DIRECTED BY HRC.

C. A MINIMUM REENLISTMENT TERM OF THREE YEARS IS STILL A REQUIREMENT FOR SRB ENTITLEMENT. A TWO-YEAR REENLISTMENT TERM DOES NOT ENTITLE A SOLDIER TO AN SRB.

D. SOLDIERS WHO REENLIST TO MEET THE SERVICE REMAINING REQUIREMENT FOR AN HQDA DIRECTED DETAILED ASSIGNMENT (SUCH AS RECRUITING, DRILL SERGEANT, OR INSTRUCTOR DUTY) ARE AUTHORIZED PAYMENT OF AN SRB FOR THEIR PMOS, SQI, ASI, OR LANGUAGE CODE, PROVIDED OTHERWISE QUALIFIED.

E. INFORMATION ON TAXABLE INCOME CAN BE FOUND IN TABLE 44-1, CHAPTER 44, VOLUME 7A OF THE DODFMR.
